

# **Emily Griffith Campus Emergency Plan**

## **Security Desk**

On-site Safety and Security staff support Emily Griffith Technical College at 1860 Lincoln (for 1820 & 1860 Lincoln), and at 1205 Osage, and initiate notification to building occupants in the event of an emergency affecting the campus. Field patrol units and Denver Police also support the day-to-day operations of the campuses and provide emergency response when needed. Should any staff member witness a crime in progress or issue that causes concern, they should immediately call 911 and then Safety and Security at 720-423-3911. For concerns not requiring police response, on-site Safety and Security staff can be reached at 720-423-3344.

At Emiily Griffith's CMC location, on-site security is provided by Rocky Mountain Public Broadcasting Service personnel. The facility is secured by badged entry, with no open ingress or egress.

Should a critical incident occur that would require the building to **lockdown or lockout**, <u>instructions will be given to each floor via the overhead paging system and phones.</u> It is imperative that these instructions are followed by every staff member and student on the floor.

During a **Lockdown**, staff and students will be instructed to remain on their floor at their work stations or in their classrooms. Movement between floors will be restricted. Work activities will cease. Individuals should silence cell phones and desk phones. No one will be allowed to enter or leave the building. (Example: A lockdown will be called if there is an imminent threat to building occupants, such as a disgruntled employee or community member.)

During a **Lockout**, business inside the building will be allowed. No one will be allowed to enter or leave the building. (Example: A lockout will be called if there is a situation unfolding outside the building, such as police activity in the area.)

#### **Building Evacuation**

The stairwells and exit doors throughout each building are marked with illuminated green exit signs. Please locate the closest stairwell to your workstation or classroom, or reference the posted evacuation routes published in all classrooms and work areas to determine the route. Should the fire alarm sound, all staff, students, and visitors will need to exit the building via one of the stairwells. Once an individual has exited the building, they should proceed to the evacuation staging area. For the 1820 and 1860 Lincoln campuses, individuals should proceed south on Lincoln Street or either west or east on 19th Ave. For the 1205 Osage campus, individuals should proceed north onto the dirt parking lot or south toward the picnic tables under the tree. For the CMC, individuals should follow instructions posted on-site. Evacuees must be 100 feet from the building during an evacuation. Do not re-enter the building until you have been given the "all clear" from Safety and Security or CMC personnel.

#### **Additional Notes:**

- EGTC/EGHS/DDES have monthly fire drills at 1860 Lincoln for floors 1-3, and 2x/year drills for floors 4-6. During a drill, only the floor where the alarm is activated plus the floors immediately above and below must evacuate.
  - During these monthly scheduled drills, strobes and sirens will be triggered on the 2nd floor so only the 1st and Salon levels of the college will be impacted.
     Security, in conjunction with EGHS, EGTC and DDES will schedule these drills to minimize impact to affected programs, e.g. culinary arts, barbering, cosmetology and esthetician.
- Fire drills at 1205 Osage are carried out 2x/year.
- Fire drills at the CMC are carried out per guidance from Rocky Mountain Public Broadcasting Service.
- Elevators will not work during a drill or real situation. Those unable to take the stairs should go to the staging area in the elevator lobby on their floor and locate the call button to alert security. - For the Lincoln and Osage campuses, see the yellow sign, with a red button. Push the red button to alert security. You will be asked to provide personal information so the necessary attention and assistance can be provided.
- Emily Griffith has color-coded maps in every room that highlight evacuation routes. For 1860 Lincoln, evacuees should utilize the following stairwells:
  - Stairwell A west side exit through the front doors and head to parking lots south of the building.
  - Stairwell B east side exit to the alley and head east up 19th Ave to parking lots close to Sherman Street.
  - Stairwell C south side used primarily by HS and DDES, but occupants of the

4th floor might use it. Exits onto Lincoln Street, head south.

## **Severe Weather/Shelter**

<u>Tornado Watch</u>: Conditions are right for a tornado.

Tornado Warning: A funnel cloud has been sighted. Take Shelter.

Watches and Warnings to take shelter are typically reported by local media outlets, Civil Defense Sirens or NOAA Radio notification. Severe weather notification may also be reported by staff or visitors if they observe conditions. Notifications via a smartphone or internet app are also prevalent. The Security Desk should be notified at 720-423-3344 of weather watches or warnings. Once the on-site security staff is aware of the situation they will make an announcement over the loudspeaker to take shelter. Anyone who feels they need to take shelter prior to an announcement, may do so immediately. During a tornado warning, individuals should move away from exterior doors and windows. Flying debris is the greatest concern during severe weather. If possible, use the stairs to find shelter on lower floors.

## Additional notes:

- People are encouraged to seek shelter as soon as they're aware of a valid threat of tornado; there is no need to wait for the announcement by Security.
- Move to interior hallways and the elevator vestibules.
- SNOW CLOSURES: Staff and students may call 720-423-3200 to find out if DPS has closed schools.

Safety and Security is everyone's responsibility. Stay alert, stay informed and take the appropriate action as necessary.

#### Additional Notes:

- Evacuation maps are available and have been posted in classrooms.
- Emergency Operations Plans have been established for the 1820/1860 Lincoln campus and the 1205 Osage campus. Designated employees (see list below) will assist in evacuations and emergency situations, and will be in contact with DPS Security.
